

Battery Replacement

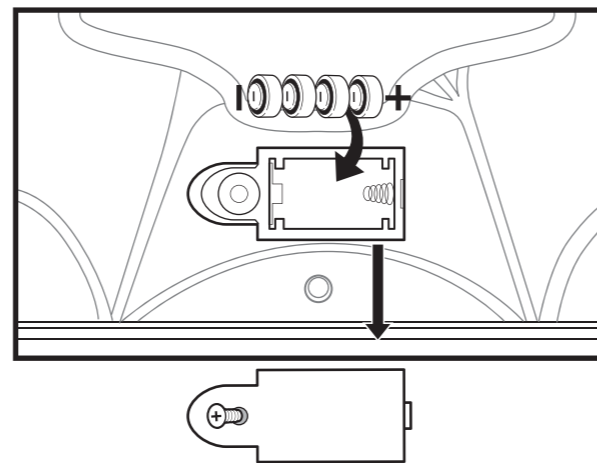
Batteries included are for demonstration purposes only. Replace batteries when sound becomes distorted.

For longer life use only alkaline batteries.

Toy requires 4 replaceable AG13/LR44 button cell batteries. To replace batteries, use a Phillips head screwdriver (not included) to open battery door. Insert 4 AG13/LR44 button cell batteries as shown. Use either AG13/LR44 button cell or equivalent. Replace battery cover and screw closed.

Note:

The batteries in the "Invisible" ink pen are NON-replaceable.



Battery Safety Information

In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the product before being charged (if designed to be removable).
- Rechargeable batteries are only to be charged under adult supervision (if designed to be removable).
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.

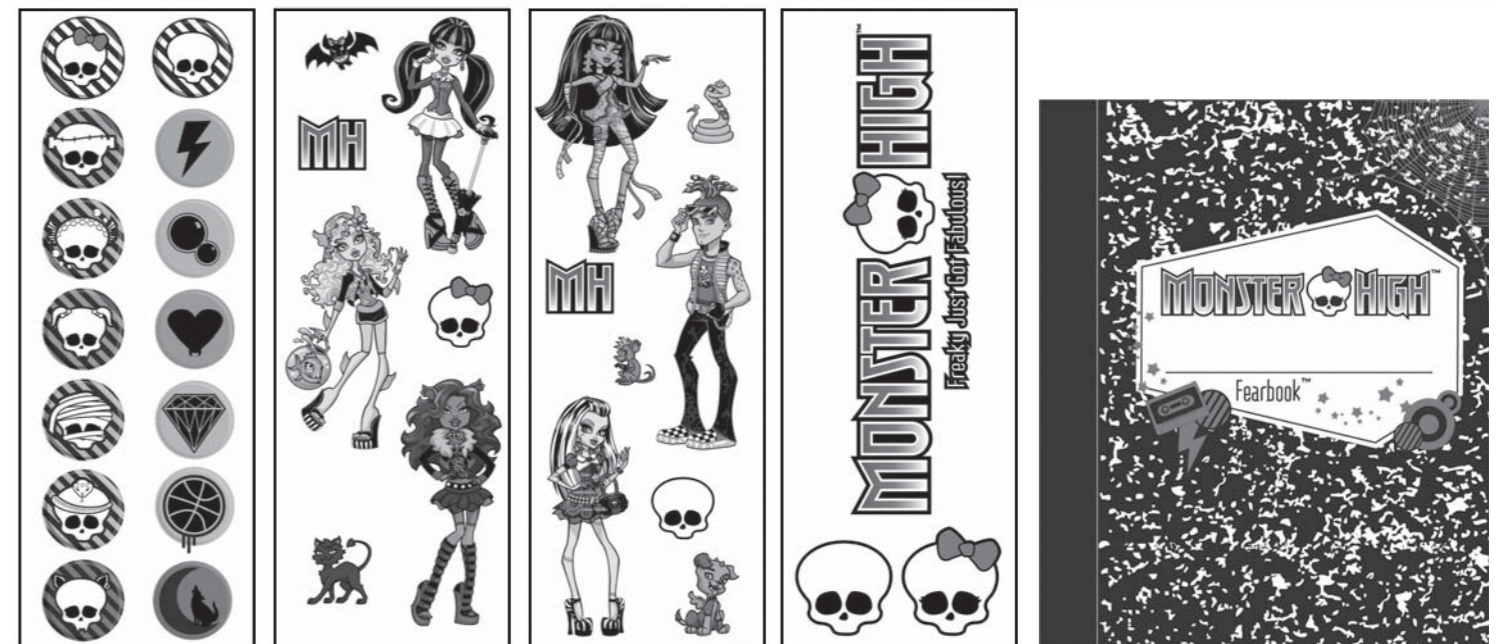

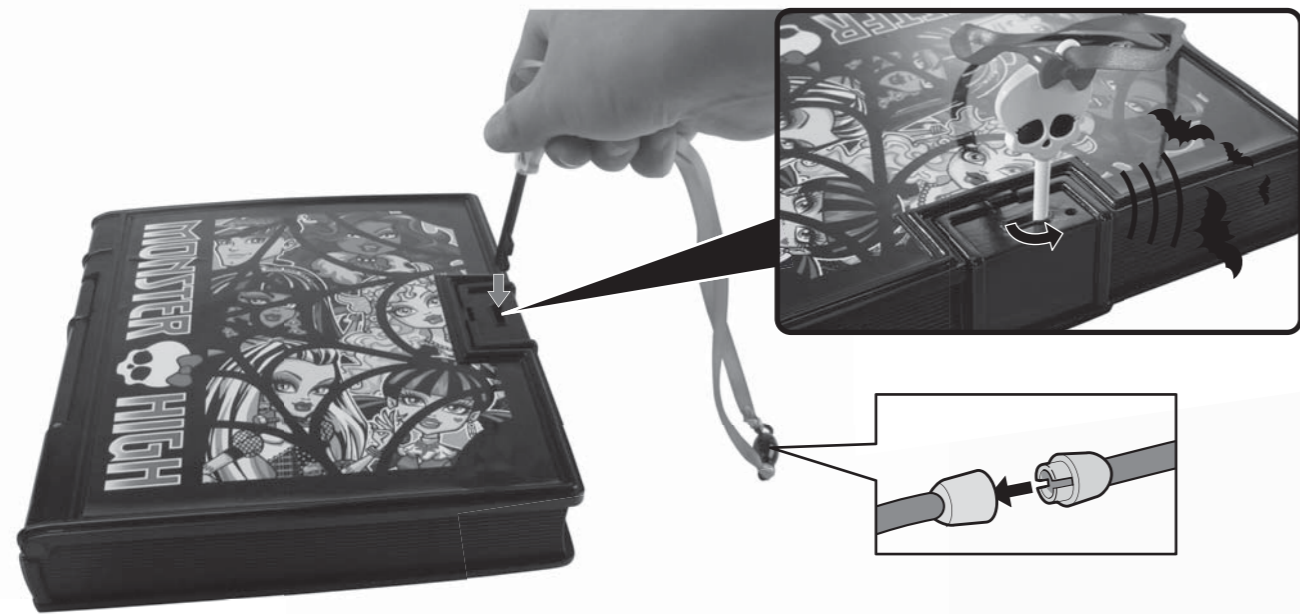

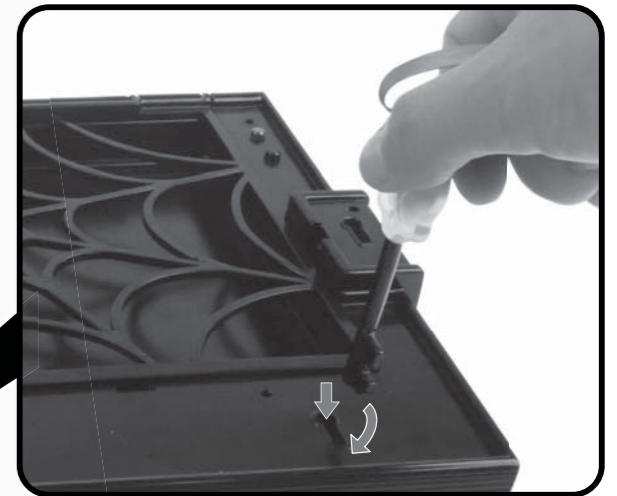


Unlock the Fearbook™ using the skeleton key to access the accessories inside and to hear cool sound effects !

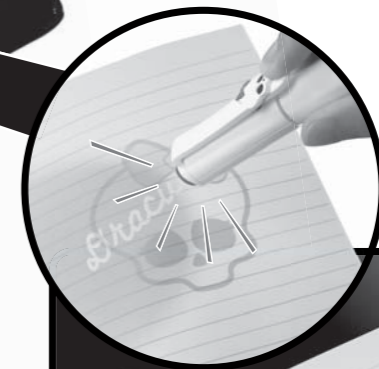
Record a secret message to play back for your friends!
