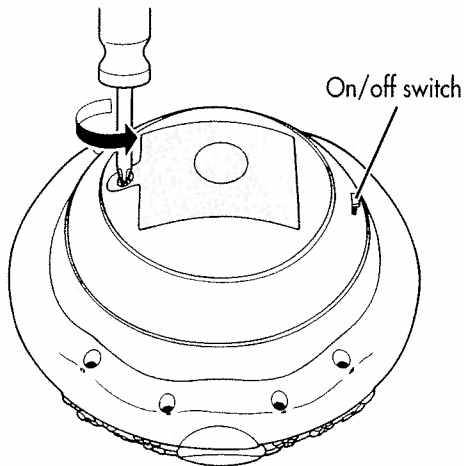

ADULTS NOTE:

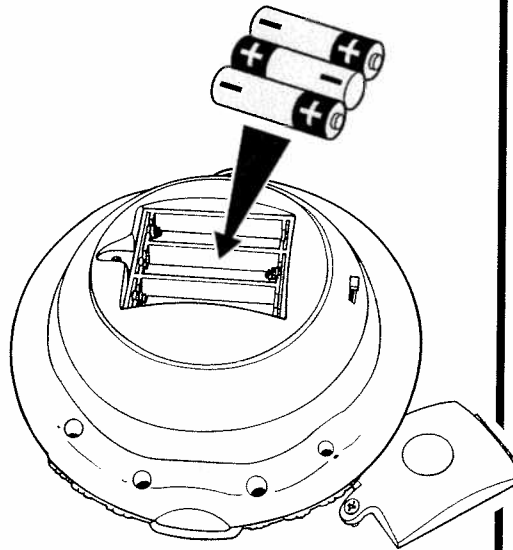
- Cut the plastic attachments with scissors and discard the pieces.

- Non-replaceable light bulbs included.
- This toy is not recommended for use on dirty or wet surfaces.
- Do not immerse in water.

BATTERY INSTALLATION:



1. Using Phillips head screwdriver (not included), unscrew door and remove.



2. Take out the old batteries, replace with 3 "AA" alkaline batteries (not included) as shown. Replace battery cover.

BATTERY SAFETY INFORMATION

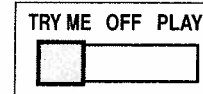
1. Non-rechargeable batteries are not to be recharged.
2. Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.
3. Do not mix old and new batteries.
4. Only batteries of the same or equivalent type as recommended are to be used.
5. Batteries are to be inserted with the correct polarity.
6. Exhausted batteries are to be removed from the toy.
7. The supply terminals are not to be short-circuited.
8. Dispose of batteries safely.
9. Rechargeable batteries are to be removed from the toy before being charged.
10. Rechargeable batteries are only to be charged under adult supervision.

Replace batteries when sound distorts or light dim.

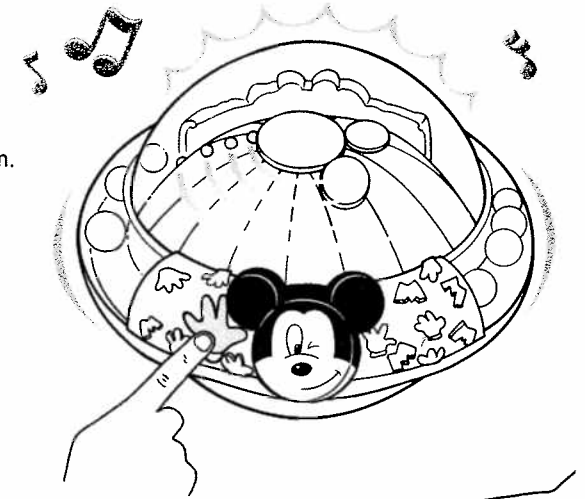
TO PLAY:

TRY ME MODE:

1. Slide switch to "TRY ME" position.

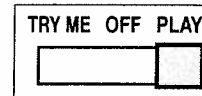


2. Press the hand-shape button, the ball vibrates with music and whirling beads.



PLAY MODE:

1. Slide switch to "PLAY" position.



2. Tap the ball and it vibrates with music and whirling beads.
