

1 INSTALL BATTERIES:

Open both sets of fabric fasteners on back of doll. Unscrew battery cover and set aside. Insert three "C" cell alkaline batteries as shown. Replace cover. **FOR LONGER LIFE USE ONLY ALKALINE BATTERIES:** Toy may not function or operate with other types of batteries



BATTERY SAFETY INFORMATION

- 1. Non-rechargeable batteries are not to be recharged.
- 2. Rechargeable batteries are to be removed from the product before they are charged.
- If removable rechargeable batteries are used, they are only to be charged under adult supervision.

 Panet mix alkaling standard (section pine) or rephaseable.
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.
- 5. Do not mix old batteries and new batteries.
- Only batteries of the same or equivalent type as recommended are to be used.
- Be sure to insert batteries with the correct polarities and always follow the toy and battery manufacturers' instructions.
- 8. Exhausted batteries are to be removed from the product.

If the doll is left on for a period of time without play, the doll will "power down" to conserve battery life. The doll's eyes reopening slightly indicate this "power down" mode.

2. SKIN CARE HINTS:

- If skin is dirty, clean with warm (85°-100° F / 29°-37° C) water and dish washing detergent or with household alcohol.
- After cleaning, allow to dry at least 2-5 minutes before use.
- Talc can be applied to smooth the surface. (Use only a very small portion.)

DO NOT do the following:

- Longtime exposure to direct sunlight.
- Apply excessive water to skin.
- Apply any type of ink.
- Apply nail polish.
- Clean with ammonia or any ammonia based detergents.
- Expose to high heat.
- Expose to sucrose-based or greasy food.

IMPORTANT NOTE: Please protect your baby's delicate skin from indentations, punctures or wrinkles. Keep her away from sharp objects, irregular surfaces and excessive heat. For instance, do not leave her out in the hot sun or inside a car on a hot day, and do not stuff her in a toy box.



3. TO PLAY:





Turn power switch to ON (▮).

Play with your doll by bouncing her several times up and down on your knee. Your doll will "giggle" and "squeal" with delight.

Insert bottle or doll's thumb all the way into mouth at an upward angle in such a way that the tip of the object makes contact with roof of doll's mouth. This will activate a "sucking" motion.



"Feed" your doll with her bottle. If you take the bottle away, your doll may make fussing sounds or say "Ba" if she is still "hungry" and wants the bottle back.

When feeding time is over, "burp" the baby by holding the doll in an upright position and patting her on the back. If you do not hear a "burp" after patting the doll more than 6 times, try patting another area on her back.

NOTE: You can press the BURPING BUTTON on the doll's back 6 times to manually activate the "burping" sound.

Lay your doll down or rock her gently back and forth. She'll drift off to "sleep"! Place your doll upright to "wake" her. Doll will make random motions and sounds without any physical interaction for approximately 6 minutes. After this, it will go into a "sleep" mode. During the "sleep" mode, the doll may open her eyes partially. This is normal. Tipping the doll forward to a sitting position or "feeding" the doll will bring it out of "sleep" mode.

When play is finished, it is important that you turn off power switch while the doll's eyes are still open.
