



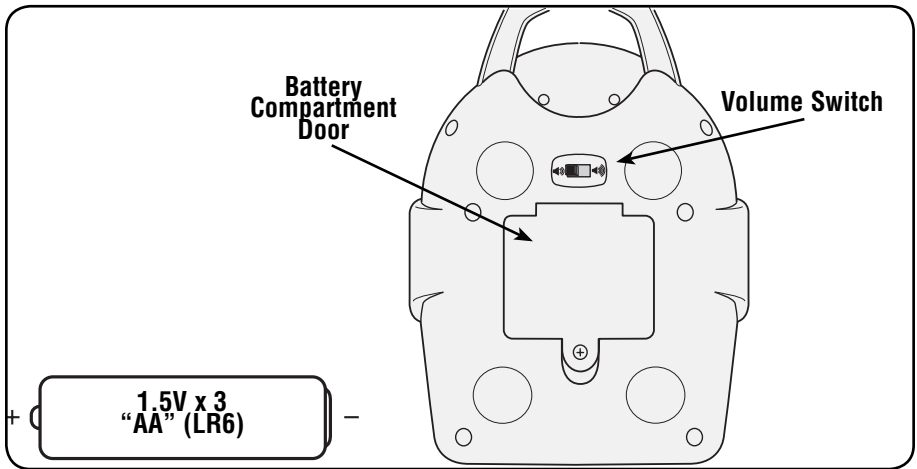
Please keep these instructions for future reference.

Requires three "AA" batteries (included) for operation.
Batteries included are for demonstration purposes only.

Adult assembly is required for battery replacement.

Tool needed for battery replacement: Phillips screwdriver (not included).

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.

- Loosen the screw in the battery compartment door with a Phillips screwdriver.
- Remove the battery compartment door. Remove the exhausted batteries and throw them away.
- Insert three "AA" (LR6) **alkaline** batteries.

Hint: We recommend using **alkaline** batteries for longer battery life.

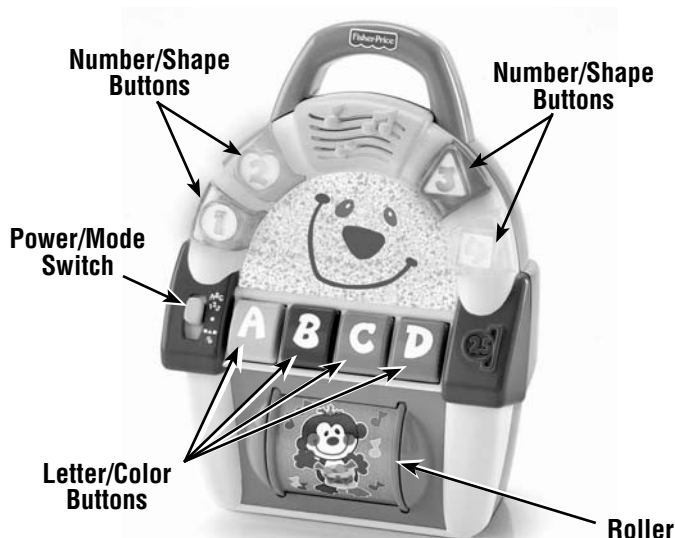
- Replace the battery compartment door and tighten the screw with a Phillips screwdriver. Do not over-tighten.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/mode switch OFF and then back ON.
- When sounds or lights from this toy become faint or stop working, it's time for an adult to replace the batteries!



Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

Let's Listen and Learn



- Slide the power/mode switch to **A B C 1 2 3** **number and letters** mode or **ABC** **colors and shapes** mode.
- Slide the volume switch to **high volume**  or **low volume** .
- Press any of the buttons to hear it identified along with a short tune and dancing lights.
- Spin the roller for a musical tune and flashing lights.
- When finished playing with this toy, slide the power/mode switch OFF.

Care

- Wipe this toy with a clean cloth dampened with a mild soap and water solution. Do not immerse this toy.
- This toy has no consumer serviceable parts. Please do not take this toy apart.
