
#### Younger children & those new to the Imaginext<sup>™</sup> System





### **Battery Installation**


- Locate the battery compartment door on the sounds and lights box.
- Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door.
- Insert two, "AAA" (LR03) alkaline batteries, as indicated inside the battery compartment.

*Hint:* We recommend using *alkaline* batteries for longer battery life.


- Replace the battery compartment door and tighten the screw with a Phillips screwdriver. Do not over-tighten.
- When sounds or lights from this toy become faint or stop, it's time for an adult to change the batteries!











- Proper label application will help to keep the labels looking their best! When applying labels, keep the following guidelines in mind:
- Wash your hands before applying the labels.
- Before applying the labels, wipe the surfaces of this toy with a clean, dry cloth to remove any dust or oils.
- Place the labels exactly as shown in the illustrations.
- For best results, avoid repositioning a label once it has been applied.








