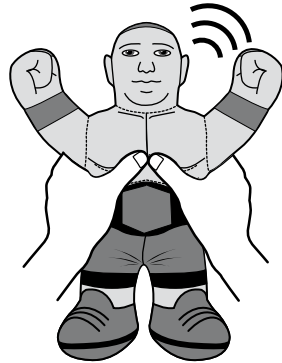
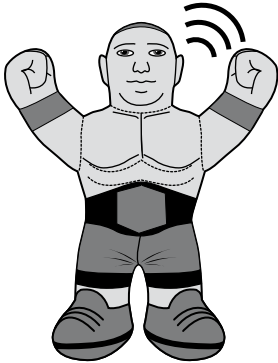

### TO PLAY



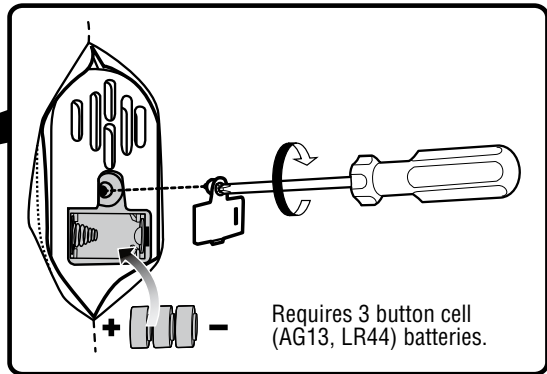
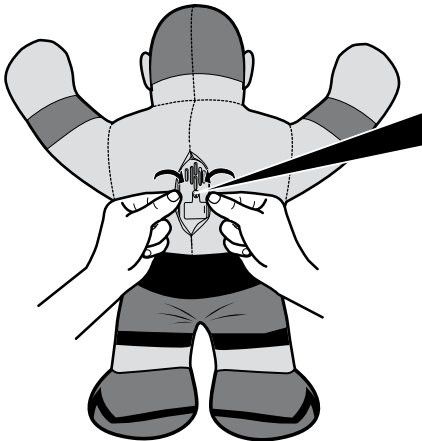
1. Brawl and grapple with Brawlin' Buddies™ for sounds, phrases, and music.

2. For entrance music, press and hold chest for a few seconds.



Note: Brawlin' Buddies™ goes to sleep when left alone. Press his chest to wake him up.

### BATTERY INSTALLATION



Requires 3 button cell (AG13, LR44) batteries.

- Batteries included are for demonstration purposes only.
- Replace batteries if sounds play slowly or distort.
- Open the fastener to reveal the battery compartment.
- Unscrew the battery cover with a Phillips head screwdriver (not included).
- Remove batteries and dispose of them safely.
- Install 3 new button cell (AG13, LR44) batteries in the orientation (+/-) shown.
- Replace battery cover and tighten screw.
- Close the fastener to cover up the battery compartment.
- For best performance, use only alkaline batteries.

## BATTERY SAFETY INFORMATION

In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the product before being charged.
