

- Keep instructions for future reference, as they contain important information.
- Requires two AA batteries (included).
- Batteries included are for demonstration purposes only.
- Battery replacement is required. Only adults should install batteries. Required tool: Phillips screwdriver (not included).
- Wipe toy with a cloth dampened with a mild soap and water solution.
- Not recommended for use on loose dirt or wet surfaces.
- For maximum distance, shake vehicle 7 or 8 times. Shaking more than this does not increase distance it will travel.

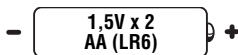
Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

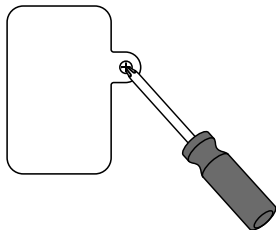
- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

CAUTION

To prevent entanglement, keep hair away from wheels.



For longer life, use **alkaline** batteries.



- Loosen the screw in the battery compartment door and remove door.
- Remove exhausted batteries and dispose properly.
- Insert two, new AA (LR6) **alkaline** batteries.
- Replace battery compartment door and tighten screw.
- If toy begins to operate erratically you may need to reset electronics. Remove the batteries for about 3 minutes and then reinstall them.
- When sounds or motions become faint or stop, it's time for an adult to change batteries.
