

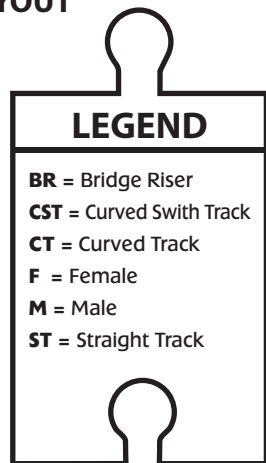


PERCY AND THE LITTLE GOAT SET

TRACK LAYOUT



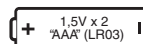
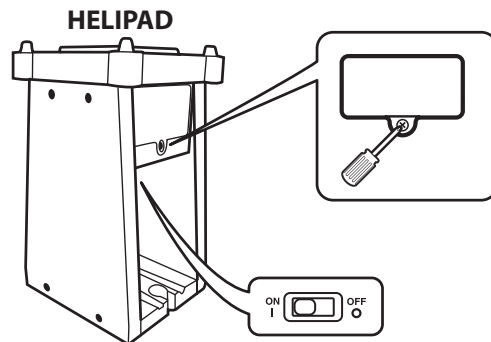
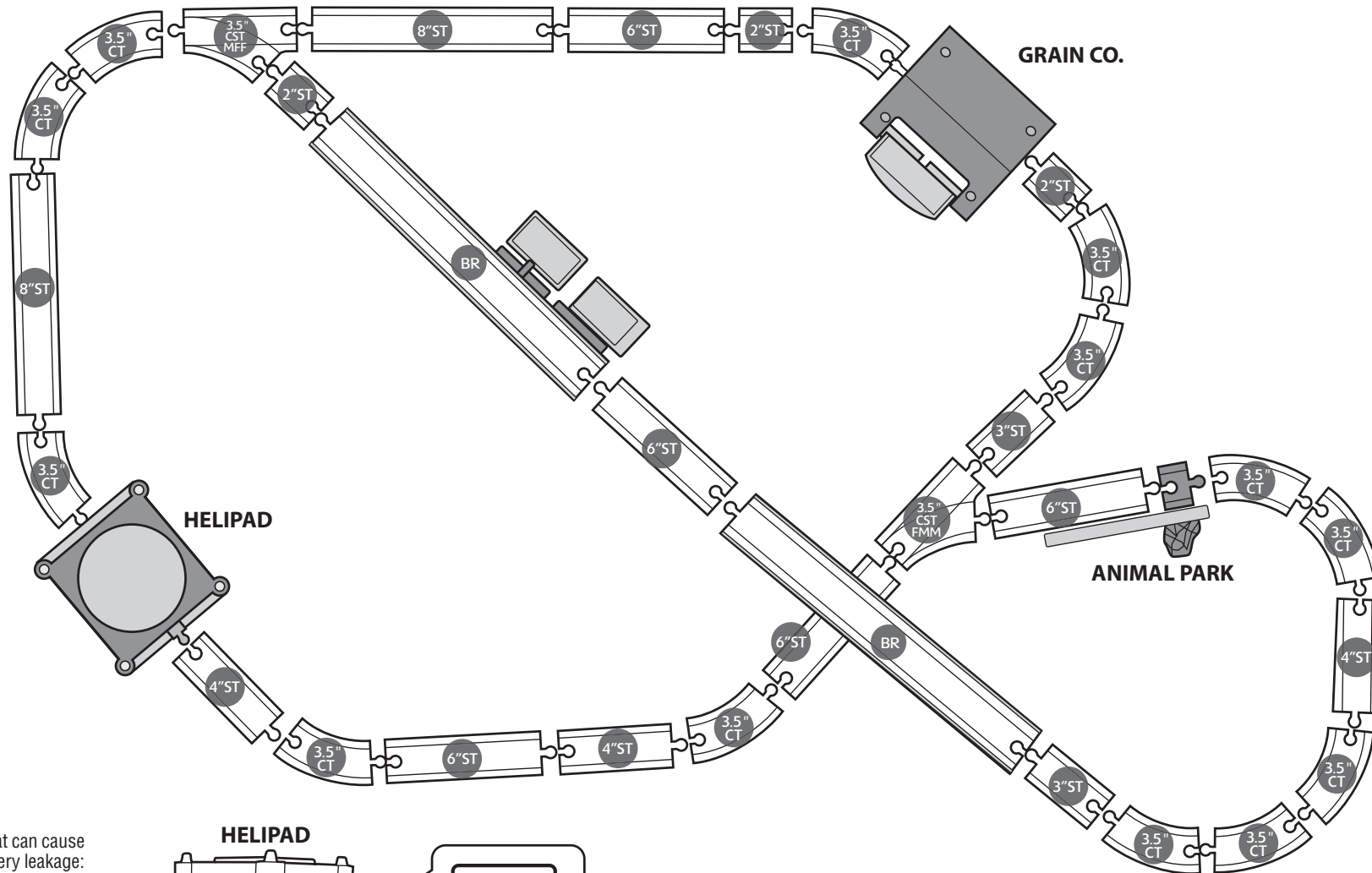
BATTERY INSTALLATION

Unscrew and lift away cover from product.
 Replace batteries as indicated inside the battery compartment. Batteries included are for demonstration purposes only.
 For longer life use only alkaline batteries.
 If the toy begins to operate erratically, you may need to reset the electronics by removing the batteries and reinstalling them.
 Requires 2 "AAA" (LR03) Batteries.

BATTERY SAFETY INFORMATION

In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the product before being charged.
- Rechargeable batteries are only to be charged under adult supervision.
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.
- Do not mix old and new batteries.
- Only batteries of the same or equivalent type as recommended are to be used.

 Phillips screwdriver (not included).



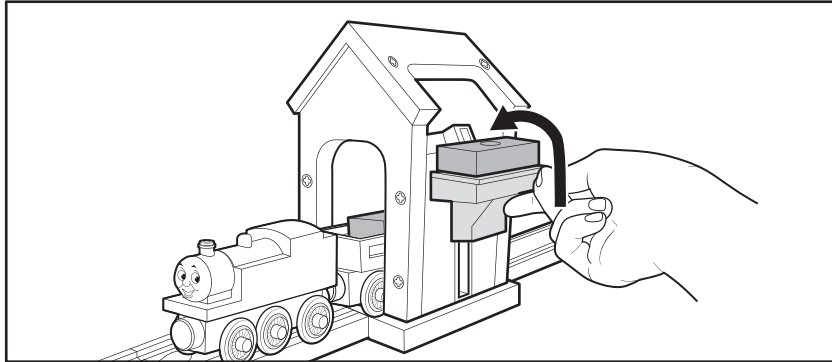

Help Percy and Harold track down the missing goat!

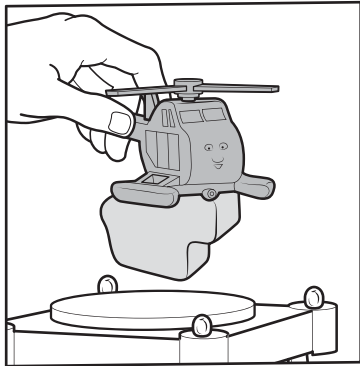
GRAIN LOADER:

Lift and flip the cargo into the grain loader.



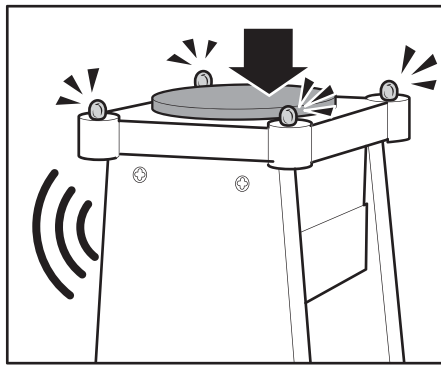
HELICOPTER:

Harold can carry the goat to safety.



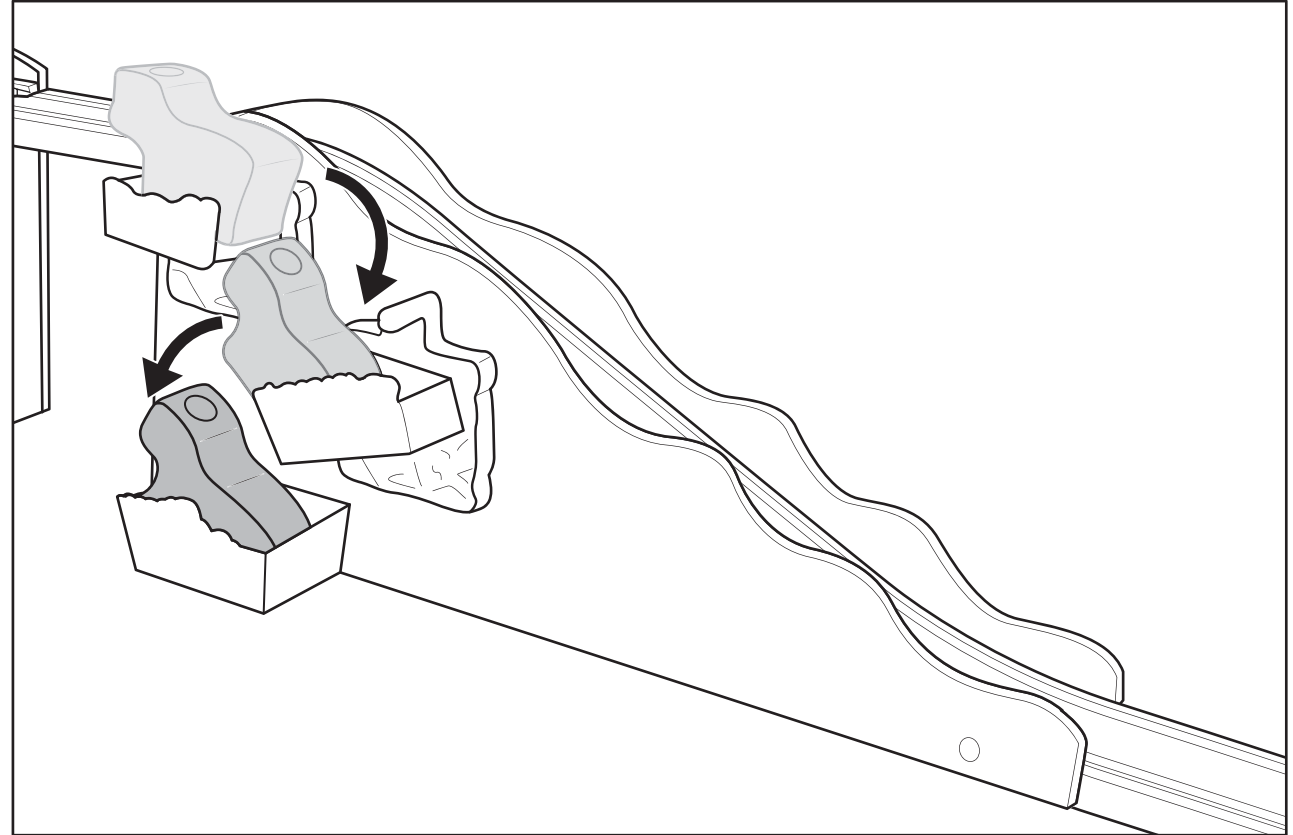
HELIPORT:
