Adult assembly is required for battery replacement.


Tool required for battery replacement: Phillips screwdriver (not included).

Before Use

A plastic tab was attached to the toy for in-store demonstration purposes. While the tab may have already been removed, check the back of the toy to be sure. If the plastic tab is still attached, open the fasteners on the back of the toy and pull and remove the tab. Close the fasteners and throw the plastic tab away.

Battery Replacement




For best results, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.

- Open the fasteners on the back of the toy to access the battery compartment.
- Loosen the screw in the battery compartment door with a Phillips screwdriver and remove it. Throw the exhausted batteries away.
- Insert three, new "AA" (LR6) alkaline batteries.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.
- Close the fasteners on the toy.
- If the toy begins to operate erratically you may need to reset the electronics. Slide the power/volume switch on the back of the toy off and then back on.
- When sounds become faint or stop, it's time for an adult to change the batteries!

Battery Safety Information



In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product.

To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.

2 Interactive Play Modes!

- Open the fasteners on the back of the toy and slide the power/volume to ON with low volume ◄»; ON with high volume ◄»; or OFF O.
- Locate the mode select switch on puppy's right foot.
- Press the right foot to turn the toy on and start in learning mode. Press again for music mode. Press once more to turn the toy off.



& Learning Mode

- Press the puppy's left foot, right hand, heart, tummy or left ear to hear it identified followed by a short ditty. Press again to learn a color.
- Press the note button on the puppy's left hand to hear fun learning songs.

- Press the puppy's left foot, left ear, heart or hands to hear a fun song. Press again to hear a fun phrase.
- Press the puppy's tummy to hear another fun song. Press again to hear the puppy giggle and bark.
