


Each motorized robot has an activation button. Press the button to start the action!

either travel in a straight line


or spin in place.



Battery Installation



- Locate the battery compartment on the bottom of the robot.
- Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door.
- Insert two "AA" (LR6) alkaline batteries as indicated inside the battery compartment.

Hint: We recommend using **alkaline** batteries for longer life.

- Replace the battery compartment door and tighten the screw with a Phillips screwdriver. Do not over-tighten.
- It's time for an adult to change the batteries when:
- -sounds are faint or stop
- -motion slows or stops
- -motion is continuous.
