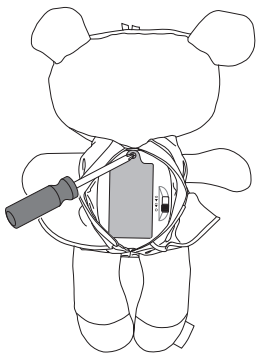

Battery Replacement



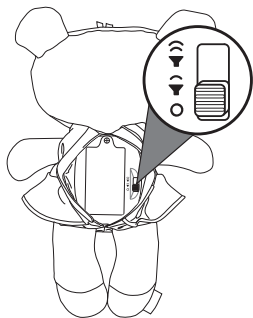
- For longer life, use **alkaline** batteries.
- Open the fasteners on the back of the toy.
- Loosen the screw in the sound box battery compartment door with a Phillips screwdriver. Remove the door. Remove the exhausted batteries and dispose of them properly.
- Insert two, new AAA (LR03) **alkaline** batteries.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.
- Close the fasteners.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and back on.
- When sounds from this toy become faint or stop, it's time for an adult to change the batteries.




Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

Power/Volume Switch

- Open the fasteners on the back of the toy.
 - Slide the power/volume switch to ON with low volume , ON with high volume  or OFF .

Care

- The toy is machine washable without the sound box. Do not immerse sound box.
- To remove the sound box, open the fasteners on the back of the toy and pull to remove.
- Machine wash cold. Gentle cycle. Do not use bleach. Tumble dry low.
- Replace the sound box back inside the toy. Open the fasteners and place the sound box back in the toy with the button facing the front of the toy. Close the fasteners.
- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities.
