







HOW TO PLAY


- 1 Load the cargo into the Post Office.

3 While he races to retrieve it, the cargo transforms inside the Post Office before emerging on the other side.




4 Use the stop-track to stop Percy, load his new cargo, and send him on his way!



BATTERY INSTALLATION

Access the battery compartment by unscrewing and separating the top half of the engine from the bottom half of the engine. Install the batteries as indicated inside the battery compartment. Re-assemble the two halves of the engine, re-insert the screw, and tighten. If the engine begins to operate erratically, you may need to reset the electronics by removing the batteries from the engine and reinstalling them.



BATTERY SAFETY INFORMATION

In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the product before being charged.
