Requires two AA (LR6) **alkaline** batteries (not included) for operation.


Adult assembly is required.

Wipe this toy with a clean, damp cloth. Do not immerse.
This toy has no consumer serviceable parts. Do not take apart.

Battery Installation

- 1,5V x 2 AA (LR6) +



- For longer life, use alkaline batteries.
- Loosen the screw into the battery compartment door with a Phillips screwdriver and remove the door.
- Insert two, new AA (LR6) alkaline batteries.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and back on.
- When sounds become faint or stop, it's time for an adult to change the batteries.

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Insert batteries as indicated inside the battery compartment.

Assembly



• Insert and "snap" the handle into the scooter. Hint: The handle is designed to fit into the scooter one way. If it does not seem to fit, turn it around and try again.

Slide the power/volume switch to ◆ ON with low volume, ◆ ON with high volume or ○ OFF.

- Slide the **Smart Stages™** mode switch to:
 - Level 1 Explore Press a button on the dash to learn shapes, listen to a song or sound effects! Press the horn for more fun sounds!
 - **Level 2 Encourage** Press a button on the dash to learn shapes and colors, or hear a song. Listen for the prompts and find the matching shape and color. Press the horn for songs and sound effects.
 - 3 Level 3 Pretend Press a button on the dash to learn traffic signals. Press the horn for more fun songs, sounds and phrases!
- Hear sound effects and musical ditties as baby scoots around in any mode!
