





Battery Replacement



- For longer life, use alkaline batteries.
- Loosen the screw in battery compartment door and remove the door.
- Remove the exhausted batteries and dispose properly.
- Insert two, new C (LR14)
 alkaline batteries.
- Replace the battery compartment door and tighten the screw.
- If toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and back on.
- When sounds/lights/motion become faint or stop, it's time for an adult to change the batteries.


Battery Safety Information



In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:
