




Keep this instruction sheet for future reference, as it contains important information. Requires three AA batteries (included). Batteries included are for demonstration purposes only.

Battery Replacement





- For longer life, use alkaline batteries.
- Loosen the screws in the battery compartment door and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three, new AA (LR6) alkaline batteries.
- Replace the battery compartment door and tighten the screws.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and back on.
- When sounds/lights become faint or stop, it's time for an adult to change the batteries.





Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:
