

screwdriver (not included).




Requires two AA (LR6) batteries (included) for operation.



Slide the power switch to ON ● or OFF O.





- For best performance and longer battery life, we recommend replacing the batteries that came with this toy with two, new AA (LR6) alkaline batteries.
- Locate the battery compartment door. Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the batteries and properly dispose of them.
- Insert two, new AA (LR6) alkaline batteries. Hint: We recommend using alkaline batteries for longer battery life.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.

- When sounds from this product become faint or stop, it's time for an adult to change the batteries.
- Wipe the toy with a clean, damp cloth. Do not immerse. This toy has no consumer serviceable parts. Do not take apart.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power switch off and back on.
