HOW TO PLAY


Before you begin, make sure the ON/OFF switch next to the battery compartment is in the ON position for lights and sounds (see battery diagram for location).







NOTE: Additional dresses and bows

REQUIRED TOOL:

PHILLIPS SCREWDRIVER

(NOT INCLUDED).

BATTERY INSTALLATION:

Unscrew and lift away cover from back of product. Replace batteries as indicated inside the battery compartment. Batteries included are for demonstration purposes only. For longer life use only alkaline batteries. If the product begins to malfunction, check the battery installation. You may need to reset the electronics by removing the batteries and reinstalling them. If the product continues to malfunction or no longer operates, remove the batteries from the toy and replace them with fresh batteries. Requires 3 "AAA" (LR03) batteries

BATTERY SAFETY INFORMATION
