

BEFORE FIRST TIME USE

Slide power/volume switch on the train to ON (with low volume ◀ or high volume ▶▶) to turn off try-me demonstration mode.



Keep these instructions for future reference as they contain important information.

Requires two C batteries and three button cell (LR44) batteries (included).

The C batteries included are for demonstration purposes only.

Battery replacement is required. Only adults should replace batteries.

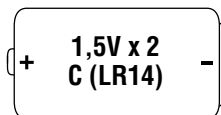
Required tool for battery replacement: Phillips screwdriver (not included).

Wipe this toy with a clean damp cloth. Do not immerse.

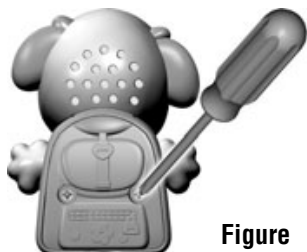
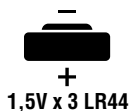
This toy has no consumer serviceable parts. Do not take apart.

Battery Replacement

For longer life, use **alkaline** batteries.

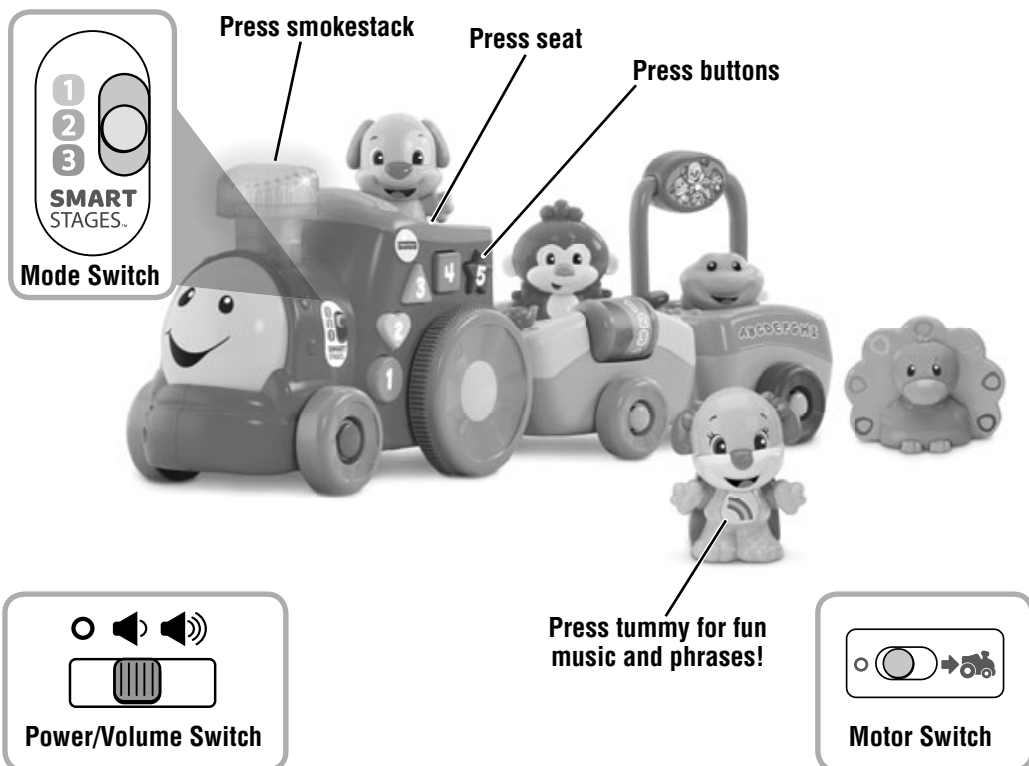
- Loosen each screw in the battery compartment doors on the train and figure. Remove each door.
- Remove the exhausted batteries and dispose properly.
- Insert two, new C (LR14) **alkaline** batteries in the train and three, new button cell (LR44) **alkaline** batteries in the figure.
- Replace each battery compartment door and tighten each screw.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch on the train off and back on. Remove the batteries from the figure and reinstall them.
- When sounds/lights/motion become faint or stop, it's time for an adult to change the batteries.

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

3 Levels of Play!



- Slide the power/volume switch on the train to ON with low volume , ON with high volume , or OFF .
- Slide the motor switch ON  to watch train roll when you press the smokestack!
- Slide the motor switch OFF  to turn off motion.

- Slide the mode switch to:
 - 1 Level 1 Explore** – Press smokestack, seat or a button for first words.
 - 2 Level 2 Encourage** – Press smokestack, seat or a button for colors, letters and more!
 - 3 Level 3 Pretend** - Press smokestack, seat or a button for role play fun!
