## INSTRUCTIONS

Keep these instructions for future reference as they contain important information.

### BATTERY INFORMATION

#### BATTERY INSTALLATION:

Unscrew and lift away cover from bottom of product.  
Replace batteries as indicated inside the battery compartment.  
Batteries included are for demonstration purposes only.  
For longer life use only alkaline batteries.  
If the product begins to malfunction, check the battery installation.  
You may need to reset the electronics by removing the batteries and reinstalling them.  
If the product continues to malfunction or no longer operates, remove the batteries from the toy and replace them with fresh batteries.  
Requires 4 "AAA" (LR03) batteries, 2 for each Engine.

#### BATTERY SAFETY INFORMATION

In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

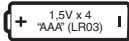
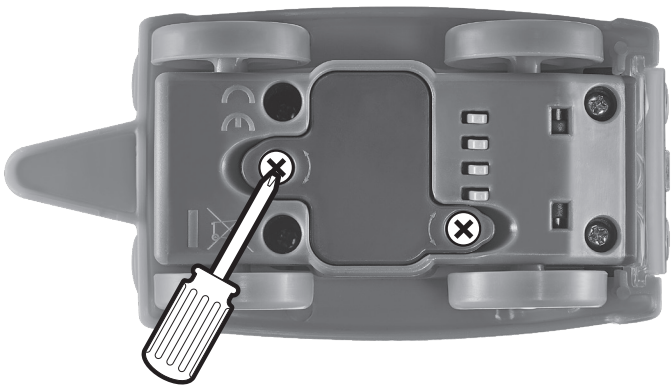
- Non-rechargeable batteries are not to be recharged.
