Clean with a damp cloth.

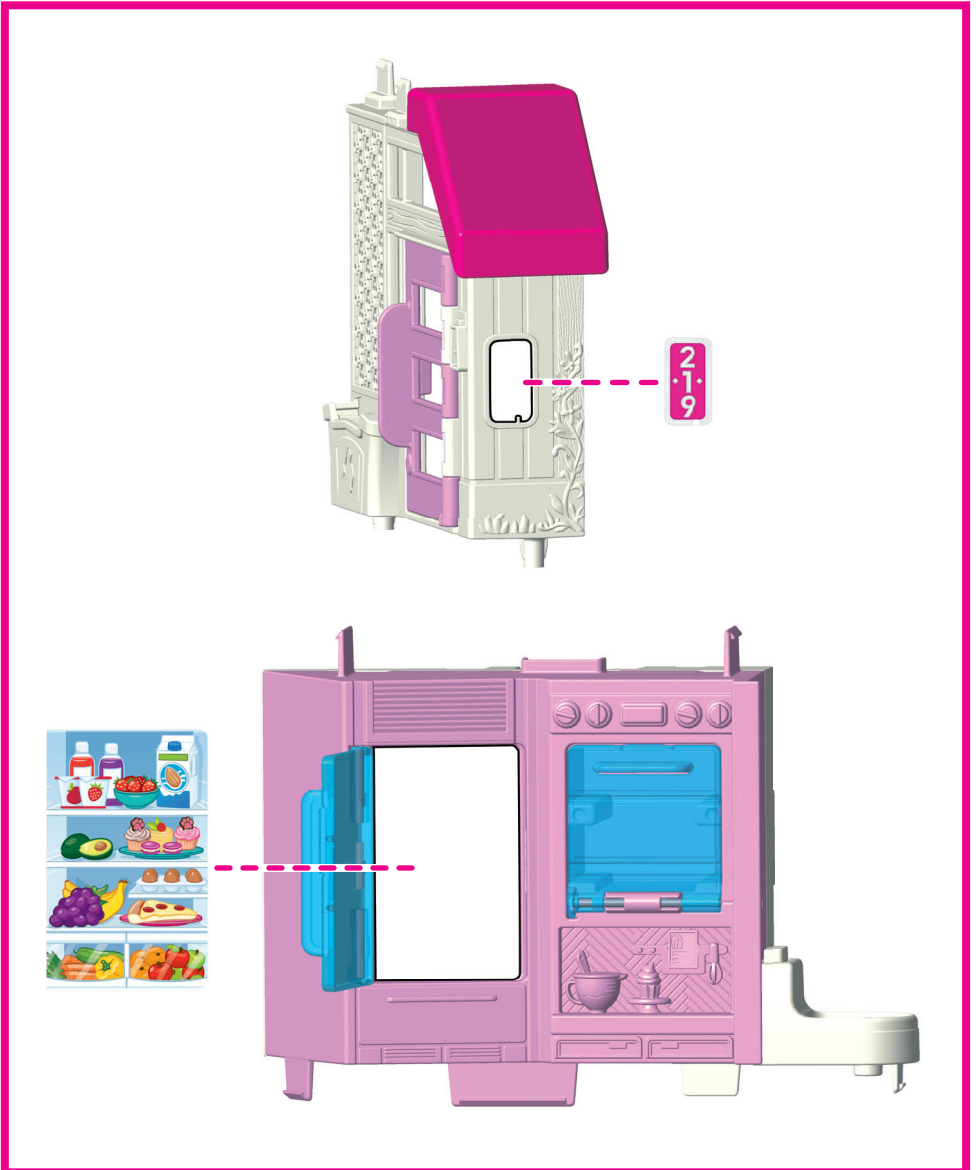

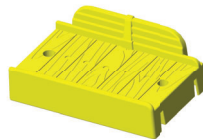
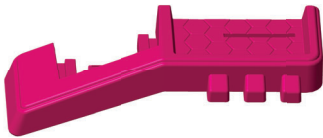
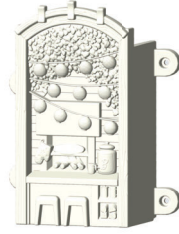
Place the labels exactly as shown in the illustrations. For best results, apply the labels before assembling the toy and avoid repositioning a label once it has been applied.

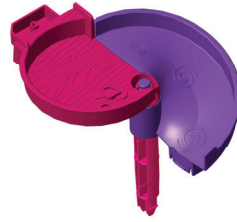

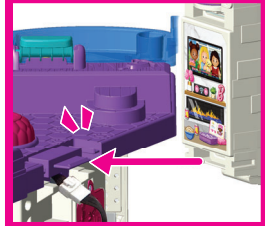
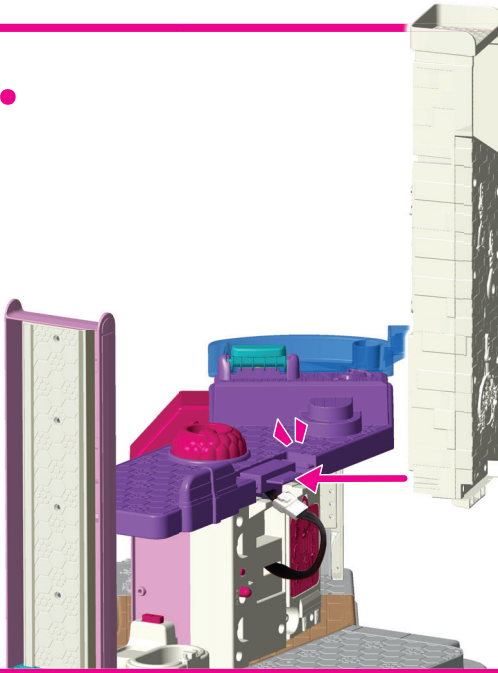
Locate the battery door on the back of the kitchen.
