- 1) Remove spiral pole.
- 2) Press and hold button while sliding rail car out of track.
- 3) Remove battery cover with Phillips head screwdriver (not included).
- **4)** Install 3 new "AAA" batteries in the orientation shown. Replace battery cover and tighten screw. For best performance use only alkaline batteries. If lights and sounds play slowly or distort, replace batteries.
- **5)** Press and hold button in while sliding rail car into track. Replace spiral pole removed in step 1.
