



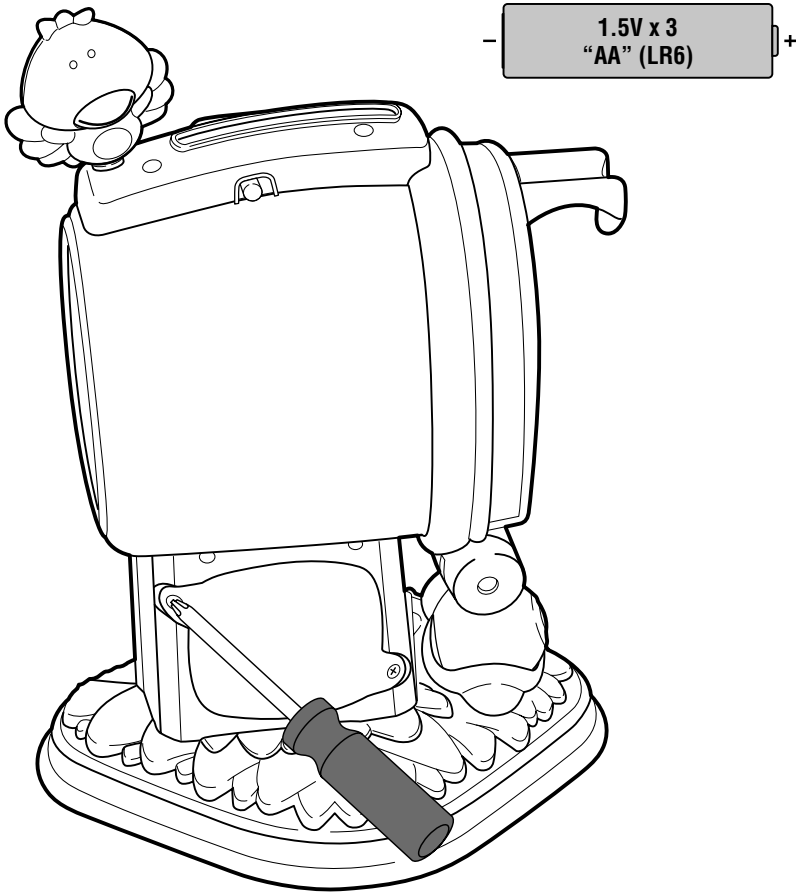
Please keep this instruction sheet for future reference,

Requires three "AA" batteries (included).

Adult assembly is required for battery replacement.

Tool required for battery replacement: Phillips screwdriver (not included).

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.

- Locate the battery compartment on the side of the toy.
- Loosen the screws in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door and the exhausted batteries. Dispose of the batteries properly.
- Insert three, new "AA" (LR6) **alkaline** batteries.

Hint: We recommend using **alkaline** batteries for longer battery life.

- Replace the battery compartment door and tighten the screws with a Phillips screwdriver.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/mode switch off and then back on.
- When sounds from this toy become faint or stop, it's time for an adult to change the batteries.

- **Music** – select for fun songs and musical tunes
- **ABC Learning** – select for counting, opposites and fun phrases
- Slide the volume switch to low volume 🗣️ or high volume 🔊.
- When finished playing with this toy, slide the power/mode switch OFF ⏻.



Battery Safety Information
