

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.

- Locate the battery compartment door on the bottom of the toy.
- Loosen the screw in the battery compartment door and remove the door.
- Remove the exhausted batteries and throw them away.
- Insert three "AA" (LR6) alkaline batteries.

Hint: We recommend using **alkaline** batteries for longer battery life.

- Replace the battery compartment door and tighten the screw.
- If this toy begins to operate erratically, you may need to reset the electronics.
 Slide the power switch off and then back on.
- When sounds or movements from this toy become faint or stop, it's time for an adult to change the batteries.

Battery Safety Information


Cool Tentacle Action!
