


Please keep this instruction sheet for future reference, as it contains important information. Requires three "AAA" **alkaline** batteries (included) for operation. Adult assembly is required for battery replacement. Tool required for assembly: Phillips screwdriver (not included). Wipe this toy with a clean cloth dampened with a mild soap and water solution. Do not immerse. This toy has no consumer serviceable parts. Do not take this toy apart.



# **BATTERY REPLACEMENT**



### For best performance, we recommend replacing the batteries that came with this toy with three, new "AAA" (LR03) alkaline batteries.

- Locate the battery compartment on the bottom of the toy.
- Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door.
- Remove the exhausted batteries and throw them away.
- Insert three, new "AAA" (LR03) alkaline batteries.

Hint: We recommend using alkaline batteries for longer battery life.

- Replace the battery compartment door and tighten the screw with a Phillips screwdriver.
- If the toy begins to operate erratically you may need to reset the electronics. Slide the power/mode switch off and then back on.
- When sounds from this toy become faint or stop, it's time for an adult to change the batteries.

## **BATTERY SAFETY INFORMATION**

### In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbonzinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removeable, rechargeable batteries are used, they are only to be charged under adult supervision.

#### **POWER/MODE SWitch**

- Slide the power/mode switch to Fun Mode I or Action Mode II .
- When finished playing with this toy, slide the power/mode switch OFF O.

### FUN

• Squeeze the handle to hear Spike laugh, burp and make other silly sounds!

### || ACtiON

- Squeeze the handle to hear Spike roar and make other ferocious sounds!
- Put the bone in Spike's mouth and squeeze the handle to hear chomping sounds!
