




# Collect Them All!

### **BATTERY SAFETY INFORMATION**

- In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not dispose of this product in a fire. The batteries inside may explode or leak.










### BATTERY INSTALLATION

Unscrew and lift cover away from top of product. Install battery as indicated inside the battery compartment. If this toy begins to operate erratically, you may need to reset the electronics. Remove the batteries from the toy and replace it. Required tool: Phillips screwdriver (not included)


