## Unload

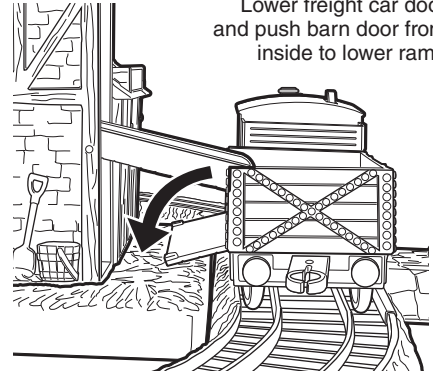

Stop Percy at the farm



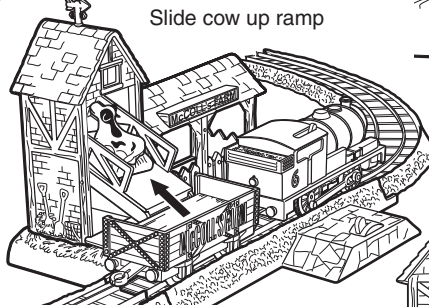
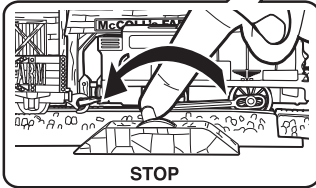

Lower freight car door and push barn door from inside to lower ramp



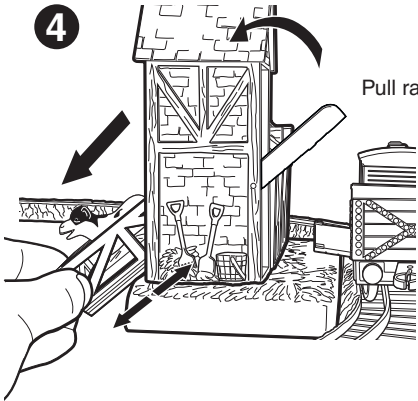

Slide cow up ramp

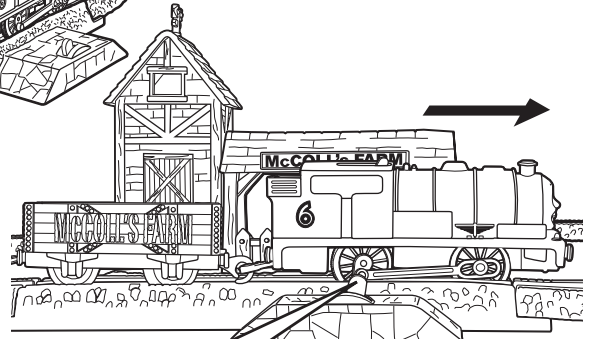

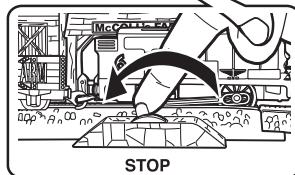
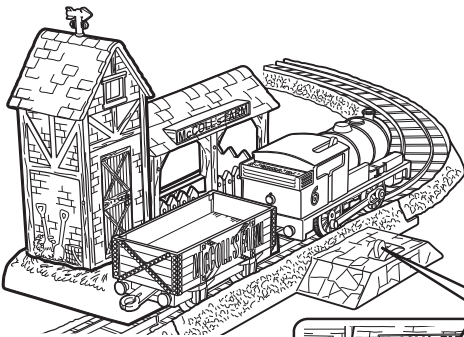


Close the freight car door and send Percy on his way!

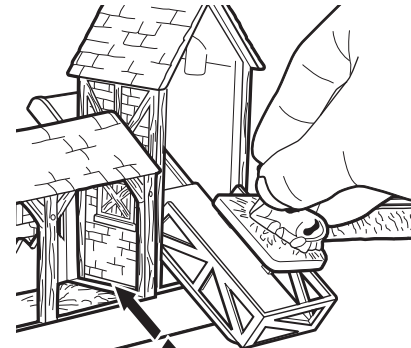

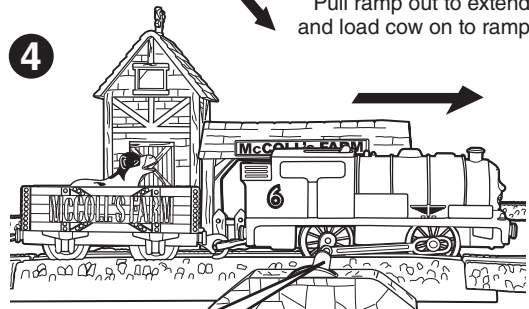

Pull ramp out to extend and load cow on to ramp

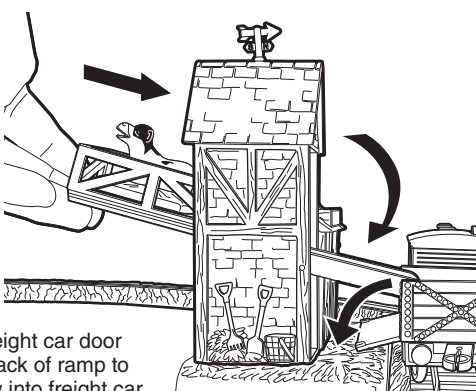

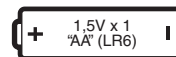


## BATTERY INSTALLATION

Unscrew and lift cover away from top of Percy.  
Install battery as indicated inside the battery compartment.  
For longer life use only alkaline batteries.  
Requires 1 "AA" (LR6) batteries.  
If this toy begins to operate erratically, you may need to reset the electronics.  
Remove the batteries from the toy and replace it.



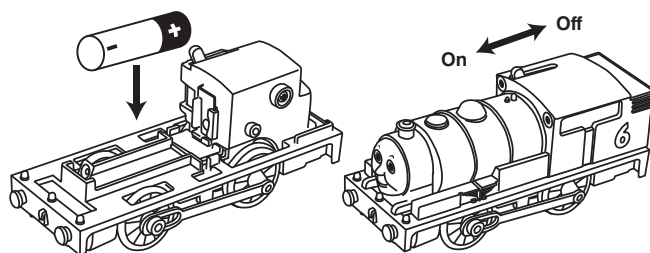

## BATTERY SAFETY INFORMATION
