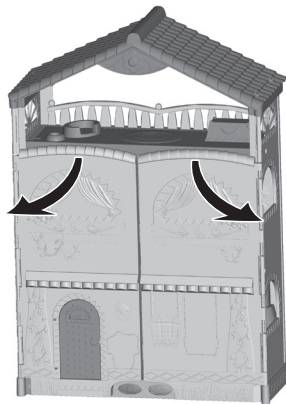
# Dora Window Surprises Dollhouse

Open the dollhouse.



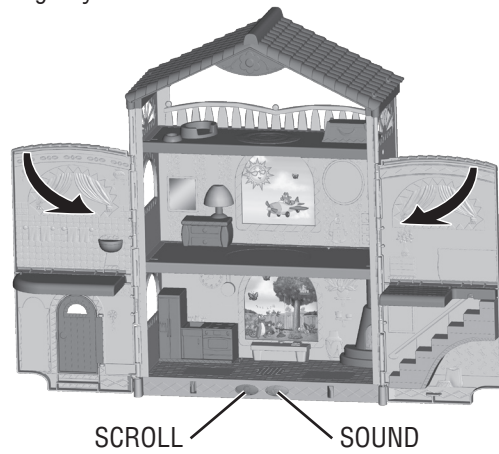
There are 7 scenes in the Dora Window Surprises Dollhouse:

To change scenes, close the dollhouse. When you open it again, a new scene will have magically appeared in the windows!

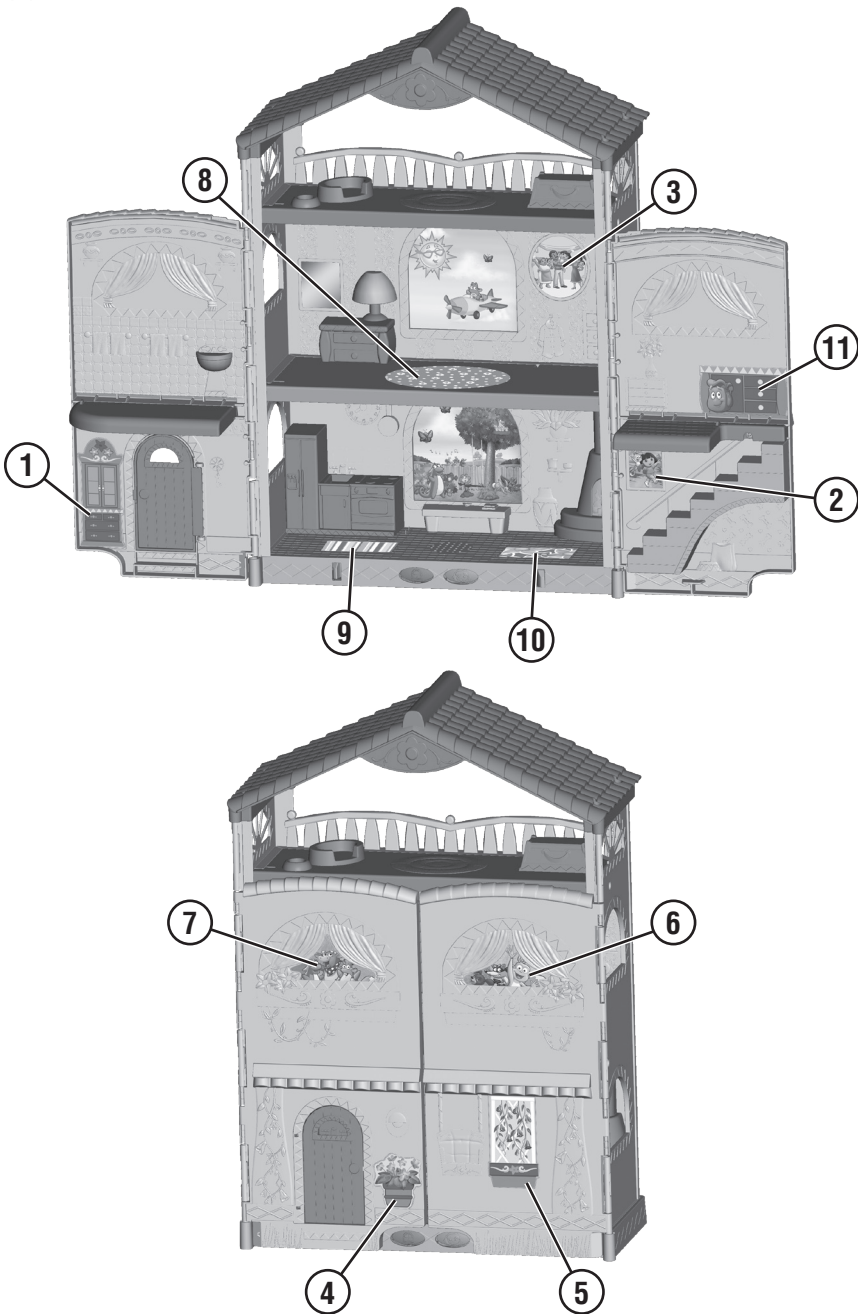
You can also change scenes by pressing the SCROLL button.

## DECAL PLACEMENT

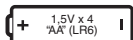
Apply the decals as shown.



## BATTERY REPLACEMENT

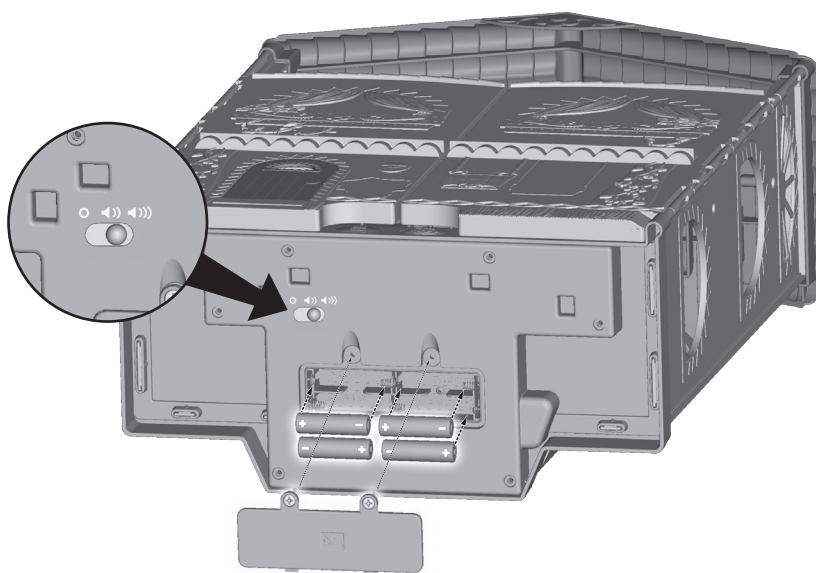
### BATTERY INSTALLATION:

Unscrew and lift cover away from bottom of product. Replace batteries as indicated inside the battery compartment. Batteries included are for demonstration purposes only. For longer life use only alkaline batteries. Requires 4 "AA" (LR6) batteries.
