



#### **BATTERY SAFETY INFORMATION**


- In exceptional circumstances batteries may leak fluids that can cause

- being charged (if designed to be removable).


   Rechargeable batteries are only to be charged under adult supervision

- Do not dispose of this product in a fire. The batteries inside may explode or leak.



# BATTERY INSTALLATION

Unscrew and lift cover away from top of product. Install battery as indicated inside the battery compartment. For longer life use only alkaline batteries. If this toy begins to operate erratically, you may need to reset the electronics. Remove the batteries from the toy and replace it.

Required tool: Phillips screwdriver (not included)
