
Adult assembly is required.

Tool required for battery installation: Phillips screwdriver (not included).




## **Assembled Parts**




# Assembly




• Fit the tabs on the cave top onto the slots in the bottom. Push to "**snap**" in place.



• Fit the fuel arm into the opening in the cave back. Push to "snap" in place.




• Fit the loop track onto the cave assembly and cave back, as shown.



• Fit the ramp track onto the front of the cave.







• Track pieces easily snap together.

• Fit the guardrail onto a curved track, as shown.


# **Track Layouts**






## Let's Go!

**Hint:** We do not recommend using the vehicle on carpets. For best performance, use on hard, flat surfaces.



• Press the power button (the windshield) on the vehicle. The ready light turns on.



- Point the remote controller toward the vehicle and push the stick forward. The vehicle moves forward.
- Pull the stick all the way back and the vehicle travels in reverse. Release the stick to stop.

# **Battery Installation**



We recommend the use of **alkaline** batteries for longer battery life.



 Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities (Europe only).

### **Vehicle**

- Loosen the screws in the bottom of the vehicle with a Phillips screwdriver. Lift the top of the vehicle off of the chassis to access the battery compartment. Insert three "AAA" (LRO3) alkaline batteries.
- Replace the top of the vehicle and tighten the screw with a Phillips screwdriver. Do not over-tighten.
- If the vehicle begins to operate erratically, you may need to reset the electronics.
   Remove the batteries and replace them in the vehicle



**IMPORTANT!** Under normal use conditions, the batteries in the vehicle will require replacement more often than the batteries in the remote controller. For additional information, refer to the troubleshooting section.

### **Remote Controller**

- Locate the battery compartment on the back of the remote controller.
- Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door and insert three "AAA" (LRO3) alkaline batteries.
- Replace the battery compartment door and tighten the screw with a Phillips screwdriver.
   Do not over-tighten.
- If the remote controller begins to operate erratically, you may need to reset the electronics. Remove the batteries and replace them in the remote controller.



# Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your toy. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the toy. Dispose of batteries safely.
   Do not dispose of this product in a fire.
   The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the toy before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

# Troubleshooting

PROBLEM	SOLUTION
Vehicle drives slowly	Battery power in the vehicle may be weak. Replace all three batteries in the vehicle with new, <b>alkaline</b> batteries.
	The wheels on the vehicle may be dirty. Wipe them with a clean cloth.
Vehicle does not respond to the remote controller	Battery power in the remote controller may be weak. Replace all three batteries in the remote controller with new, <b>alkaline</b> batteries.
	You may be beyond the maximum range of the remote controller which is about 12 feet (3,6 m).
	You may not have a clear path between the remote controller and the vehicle. This toy works best when there are no obstructions between the vehicle and the remote controller.
	Bright sunlight or fluorescent lights may affect the range of the remote controller. Try dimming the room you are playing in.
	The vehicle may have shut off. If you do not operate the remote controller for a few minutes, the vehicle shuts off automatically and the ready light turns off. Press the power button on the vehicle, and operate the remote controller to restart.
