


RISKY RAILS BRIDGE DROP







1 LOADING STATION (2 pieces)




NOTE: All gray parts are "one-time snaps" - once they are put together, they cannot be taken apart.








Once the boulder is in the cargo basket, release the cargo basket down the zipline by lifting the hook.




NOTE: If the basket doesn't make it all the way down the zipline, adjust the tension making the zipline tighter. (See STEP 1)




6 Once Thomas arrives at the bottom of the zipline he will stop to pick up the boulder again. Set the STOP/GO switch at the bottom of the zipline to the GO position and send Thomas on his way.

NOTE: MAY NOT WORK WITH ALL ENGINES.


2-way Split

NOTE: Adults should remove & discard rubber bands holding tracks together.

Unscrew and lift cover away from top of Thomas.

Install battery as indicated inside the battery compartment.

Requires 1 "AA" (LR6) battery.




