for siren lights and sounds.



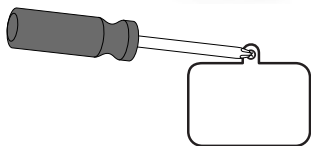

Adult assembly required.
Required tool: Phillips screwdriver (not included).



Requires three AAA batteries (included) for operation. Batteries included are for demonstration purposes only.



- For best performance and longer battery life, we recommend replacing the batteries that came with this toy with three, new AAA (LR03) **alkaline** batteries.
- Locate the battery compartment door. Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the batteries and properly dispose of them.
- Insert three AAA (LR03) **alkaline** batteries.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.
- Slide the power switch ON ● or OFF ○.
- When sounds/lights from this product become faint or stop, it's time for an adult to change the batteries.
- Wipe the toy with a clean, damp cloth. Do not immerse. This toy has no consumer serviceable parts. Do not take apart.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power switch off and back on.

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
