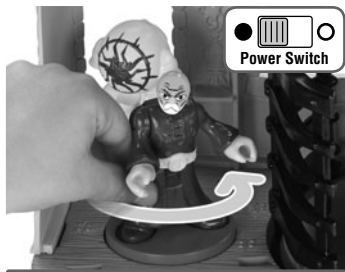

## Let's Play!



- Slide the power switch on the tower to ON ● or OFF ○.
- Turn the disk to make the Wizard's crystal ball spin.



- Take the dragon to the front of the tower. Then, press the button on the dragon and the tower will respond!

### Recognition Tips:

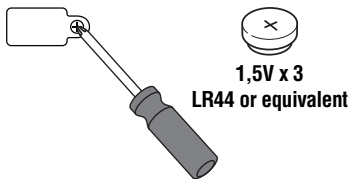
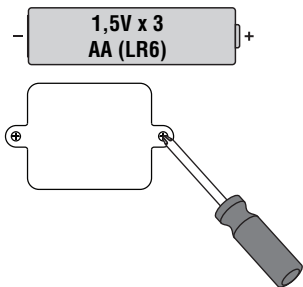
- The maximum range between the tower and dragon is 12 feet (3,7 m).
- Bright sunlight or fluorescent lights may affect this range. Try dimming the light in the room you are playing in.
- Make sure there is a clear path between dragon and tower and there are no obstructions between them.
- If the tower does not respond to the dragon when you press the button, you may need to replace the batteries in the dragon with three, new button cell (LR44) **alkaline** batteries.



- Turn the disk to open the chamber and make the dragon glow!

# Battery Replacement

For longer life, use **alkaline** batteries.



## Tower

For best performance, we recommend replacing the batteries that came with the tower with three, new AA (LR6) alkaline batteries.

- Locate the battery compartment on the tower.
- Loosen the screw in the battery compartment door with a Phillips screwdriver and remove the door. Remove the exhausted batteries and dispose of them properly.
- Insert three new AA (LR6) **alkaline** batteries.
- Replace the battery compartment door and tighten the screw.
- If the tower begins to operate erratically, you may need to reset the electronics. Slide the power switch off and back on.
- When sounds/light from this toy become faint or stop, it's time for an adult to change the batteries.

## Dragon

- Locate the battery compartment on the dragon.
- Loosen the screw in the battery compartment door with a Phillips screwdriver and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three, new button cell (LR44) **alkaline** batteries.
- Replace the battery compartment door and tighten the screw.
- If the dragon begins to operate erratically, you may need to reset the electronics. Remove the batteries and reinstall them.
- When interaction between the tower and dragon becomes faint or stops, it's time for an adult to change the batteries.

## Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.
