

**BATTERY INSTALLATION:**



- For extra support when drilling, children can place one hand on the I-beam while the other hand uses the Power Drill to fasten and loosen the Mega Bloks® screws.






Hex:




## HOW TO CHANGE TOOLS

Phillips Head/Flathead:



Align the screwdriver bit with the hex and insert until it snaps into place. To switch from Phillips head to flathead, pull the piece out and insert the other way.

Drill bit:




To use the regular drill bit, detach hex piece by pulling it out of place and snapping it into the storage compartment on top of the drill.
