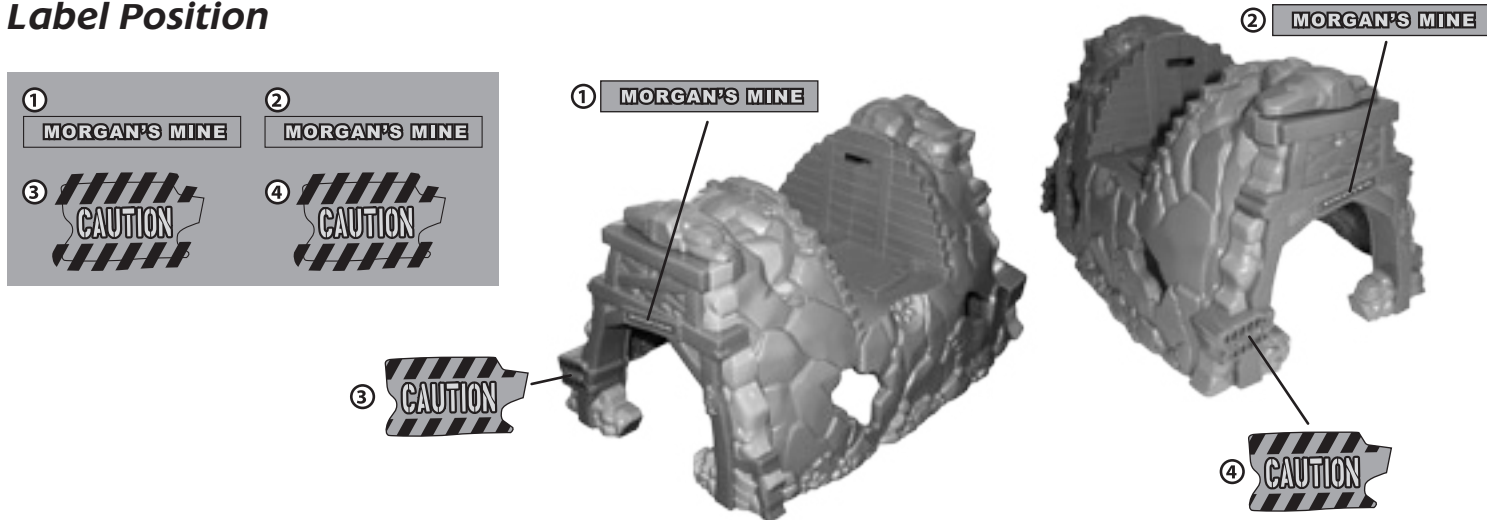

BATTERY INSTALLATION

Unscrew and lift cover away from products. Install batteries as indicated inside the battery compartment. For longer life use only alkaline batteries. If this toy begins to operate erratically, you may need to reset the electronics. Remove the batteries from the toy and replace it. Requires 1 'AA' (LR6) battery for Thomas, 2 'AA' (LR03) batteries for Light-Up Track.

BATTERY SAFETY INFORMATION

- In exceptional circumstances batteries may leak fluids that can cause a chemical burn injury or ruin your toy (product). To avoid battery leakage:
  - Non-rechargeable batteries are not to be recharged.
